Old Business: Waived reading of the prior minutes

New and Ongoing Business:

- 1. A **mildew** issue was discussed in building 12 Foxwood Drive.
- 2. Several bushes will be hard-cut at the **kiddie pool**.
- 3. Fox 3 is scheduled for **dryer vent replacement** and has 26 left to do.
- 4. We will install a **safety bin below the chlorine** containers at the pool.
- 5. Fox 2 **sidewalks** are to be sealed. Fox 1 and 3 to follow with remediation and sealing.
- 6. The **cement curbs** will be further repaired.
- 7. The **parking lot curbs** in Fox 1 will be the next to be repaired, probably this week.
- 8. The evergreen tree at the 4 corners will be transplanted to Fox 1.
- 9. Open work orders were reviewed.
- 10. We are considering more **lights and changing the bulbs** to reflect downward.
- 11. The 2nd cleaning and sealing of **lobby stones** will be done this fall.
- 12. The **roof cleaning material** is in, and the cleaning will be scheduled.
- 13. The **Rules & Regulations** were updated and unanimously approved. The significant changes are to **remodeling**.
- 14. The **crawlspace of 20 Manville Lane** is being done by Wall-to-Wall Contacting.

- 15. Fox 2 will inspect the **storage areas in the basements.** Nothing may be left in the halls. No tires, upholstered furniture, beds or clothing should be stored, as they present a fire hazard.
- 16. We are looking to enhance **recycling** signs. We are also testing taller recycle bins and making one of the dumpsters for cardboard and paper only.
- 17. Fox 1 will be the next area to install **emergency bulbs in the lobbies.**
- 18. We started evaluating the **missing glass in light fixtures**; a database was created. Fox 1 is complete.
- 19. Staircases will be re-stained and repaired on an as-needed basis.
- 20. **Improper rental/usage** procedures were discussed and will be reviewed. A deeded owner must occupy the unit.
- 21. The Village of Pleasantville has asked us to do remediations to our **catch basin**.
- 22. We will be renting a **dumpster for a fall clean-up**. Residents will be able to hire our ground personnel for help discarding their items.
