FOXWOOD HOMEOWNERS ASSOCIATION MINUTES December 7, 2021

The FHA Meeting was called to order at 7:15 PM.

Old Business: Waived reading of the prior minutes

New and Ongoing Business:

- 1. Discussions were had with respect to **smoke detectors**, all of which are new within the last few years.
- 2. We thank the resident who made a **donation for a new tree** on Manville Lane by building 16.
- 3. Ongoing **dryer vent replacement** will continue in Fox 2 & 3.
- 4. **Dryer vent cleaning** is complete.
- 5. As residents move, **storage units** are cleaned and painted as needed.
- 6. We have **remediated sidewalks** mostly in Fox 2, Fox 1 to follow shortly and Fox 3 in the spring. The recommendation to seal the new roads is to wait 3 years to let the roads "cure".
- 7. A general update was had regarding the **pool and its appurtenances**. The slop sink was replaced, as was the water heater (for the baths), and the electric panel have all been replaced in the last couple of years.

- 8. In preparation for a new tree to **replace the Copper Beech at the 4 corners** next spring, soil is to be tested & a safe dig will be done to be sure depth is not burdened by wires etc. This will be a Garden Club expense. A temporary pine tree will be placed there shortly, then re-purposed.
- 9. As a reminder, **doorbells with cameras** are not permitted.
- 10. The inside of the garbage sheds are being painted white now.
- 11. The owner of the **south adjacent property** to Foxwood is actively working on selling the property. Thorough discussions were had on this topic after discussions with the mayor and the property owner.
- 12. We continue discussing options for **updating our lobbies**, including new mailboxes and fire extinguishers.
- 13. **Tree work** by building 40 is done.
- 14. Open work orders were reviewed.
- 15. The **roof cleaning material** is in and the cleaning will be rescheduled.
- 16. The 2nd cleaning and sealing of **lobby stones** will be done in the spring.
- 17. The **dumpster** was filled and is gone, as a reminder, bulk garbage can go out on Sunday late afternoons but never any metal or tires. Please check Pleasantville's website for a more expanded list.
- 18. The **crawlspace of building 4** is very close to starting remediation with bids in and examinations done.
- 19. We are looking into **enhancing recycling signs** since many residents are still not recycling properly. We are also considering a possible **re-design of refuse areas** including taller recycle bins, and making one of the dumpsters for cardboard and paper only.
- 20. Architect plans are in for buildings 17 & 44 Foxwood Dr. and are being reviewed with the contractor.

- 21. Chimney inspections must be done by unit owners, a notice has gone out on this, please get your certificate of completion to the office.
- 22. All residents must take up **carpets on their decks** this time of year. Deck carpets can cause wood to rot.
